3. Information Only

Minutes

3.a. PA Department of Education's Special Education Program Compliance Monitoring

The Camp Hill Special Education Department will participate in the PA Department of Education's Compliance Monitoring for Continuous Improvement this school year.

Ms. Reely went over the main components; Facilitated Self-Assessment, Educational Benefit Review, Student File Reviews, Bureau of Special Education interviews with select parents, teachers and administrators, and the Bureau of Special Education optional survey link provided to parents and teachers. There will be an on-site monitoring will be on February 26, 2024. All those items will be complete by then.

5.d. Superintendent - Mr. Serfass

Mr. Serfass reported that due to a water main break on Chestnut Street, there was a 2 hour delay at the Middle/High School. He thanked the Building and Grounds department, Administrators, Borough personnel and parents for their collaboration and cooperation. PA American Water had the repairs done by the next morning.

The District has students participating in the Special Olympics on Wednesday. The event is at East Pennsboro School District.

The Enrollment Report is attached. Enrollment is up 17 students from the end of last school year.

6. Comments from Citizens

Minutes

Caroline Macharachu, spoke in regards to Safeschools data in relation to the CAC for DEI. She stated that going back to the 2017-2018 school year, there are no racial and ethnic intimidation incidents listed. Existing programs work. CAC for DEI bylaws say they have to establish goals, but no goals have been established.

Meredith Bowen, spoke about the reasons for CAC for DEI to continue. There have been racial incidents, but they may not be reflected on online data because of the way the reporting works. Important to talk to kids about what may hurt people's feelings.

7. Report of Committees

Minutes

7.a. Athletic - Mr. McInroy

Mr. McInroy reported that the Committee has not met since August. Sports teams are wrapping up their fall seasons.

Football has a 4/4 record with 2 games remaining. They are currently in 4th place.

Field Hockey is currently in a playoff position in Districts with a record of 9/4.

Girls Tennis has a record of 11/3, District playoffs as 7th seed.

Golf sent two players to Mid Penn, Jack Stewart and John Waldner made district tournament.

Both Soccer teams are sitting in 2nd place.

Cross Country has a meet on October 28 with Big Spring and are currently ranked 3rd.

Sign-up sheets for winter sports are in the schools now.

Mr. Serfass shared that the Steel High Superintendent emailed him to show his appreciation for the community at the football game when their quarterback reached the all-time career passing record for PA. It was well done by the booth, announcer, fans and athletes.

7.b. Budget and Finance / Personnel - Mrs. Kennedy

Mrs. Kennedy expressed her appreciation for the follow up information about the student work study program. She requested that the Board be notified if a student participates.

Mr. Serfass stated that Mr. Ammerman did get the Health Insurance numbers and will present them at the Budget and Finance Committee meeting.

7.c. Building and Grounds - Mr. Gale

Mr. Gale reported that the committee had a meeting on September 15.

The committee discussed the following:

• Eisenhower/Pollock Center door project to create separation between the buildings. Doors have been ordered and are scheduled to be installed over the Thanksgiving and Winter Breaks.

- HVAC at the Middle/High School
- Storage building for theater storage. Currently the Pollock Center rents storage space. The design work for the building has begun.
- Indoor batting cage building for baseball and softball. Some surveying has been done.
- Noise from Pickleball courts. Ideas to reduce neighborhood disruption are limiting hours, swipe card access, and soundproof panels. Some options will be expensive.

7.d. Community Engagement / Governmental Relations - Mrs. Gurgiolo

Mrs. Gurgiolo reported that the committee met September 21.

The committee discussed the following:

- CAC for DEI renewal of committee and bylaws. Mrs. Gayner gave an update of the CAC for DEI initiatives.
- In the CAC for DEI bylaws, under article 1, section 2, explains the purpose and mission. Article 5, section 2 states that the goals will be reviewed by the committee yearly, not the board.
- CAC for DEI Lion Connection program will matching new families to current families. Clearances will be on file with the CAC for DEI. Working on flyer to distribute to schools and community.
- Challenges of pre-breakfast program such as lack of staff, lack of equipment, lack of resources, scheduling barriers, among others. Nurses have breakfast bars if students need access to those at any time.
- Mrs. Grim, the Cafeteria Manager, went over the strict guidelines for menu planning
- As of January 1, there will be two non-meat items daily in the cafeterias.
- Town Hall November 17 at 7:00 pm about the Leader in Me program.

The next meeting is this Thursday.

7.e. Curriculum and Extracurricular Activities - Mr. Connelly

Mr. Connelly reported that the committee was given a preview of the Leader in Me MRA data which will be presented at the Town Hall on November 16.

Looked at ongoing update on the Comprehensive Plan, which will go to the Community Engagement Committee in February and the Board in March.

Instead of all building happenings being brought to the Board, just the items that are most pressing or need to be voted on by the Board will be presented. Building updates will be attached to the Curriculum and Extracurricular Activities minutes

7.f. Policy - Mr. Lamay

Mr. Serfass reported that the policies that have been approved by board are now on website as active.

The District is not going to proceed with 004.1 Policy because we will hear from students at the board meetings, but not having seats on the Board.

Mr. Gale reported that the committee discussed the following:

- Pickleball noise complaints.
- Crossing Guards are through a new company this year.
- Emergency planning cooperation between the Borough and the District
- Eisenhower walkway/underpass project is getting underway in October
- Borough has concerns about the abuse of the track such as not wearing proper footwear and people going
 in the out turnstile. They added cameras and hope that will help.

Mr. Latham noted that in general, there is better communication than there has been in the past due to these meetings.
